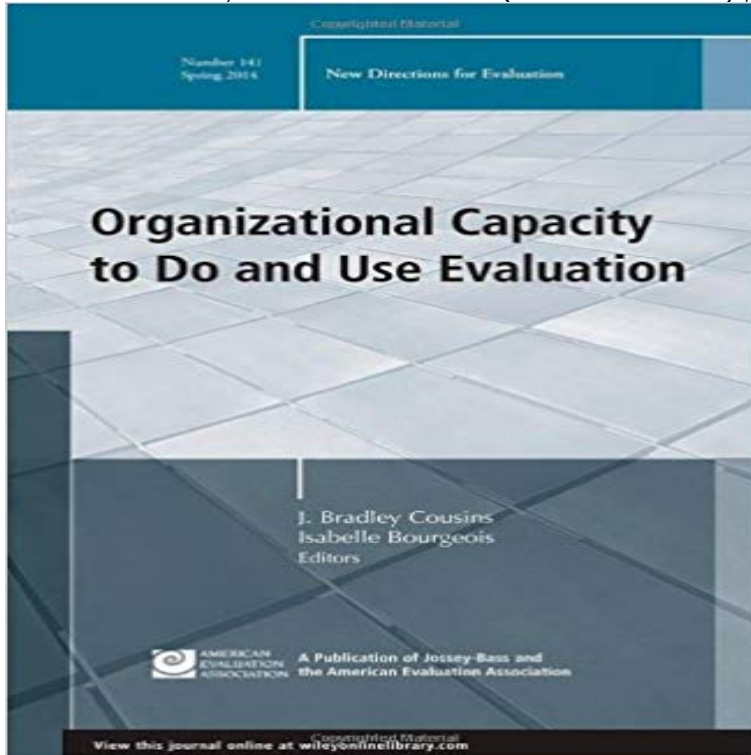


Organizational Capacity to Do and Use Evaluation: New Directions for Evaluation, Number 141 (J-B PE Single Issue (Program) Evaluation)
