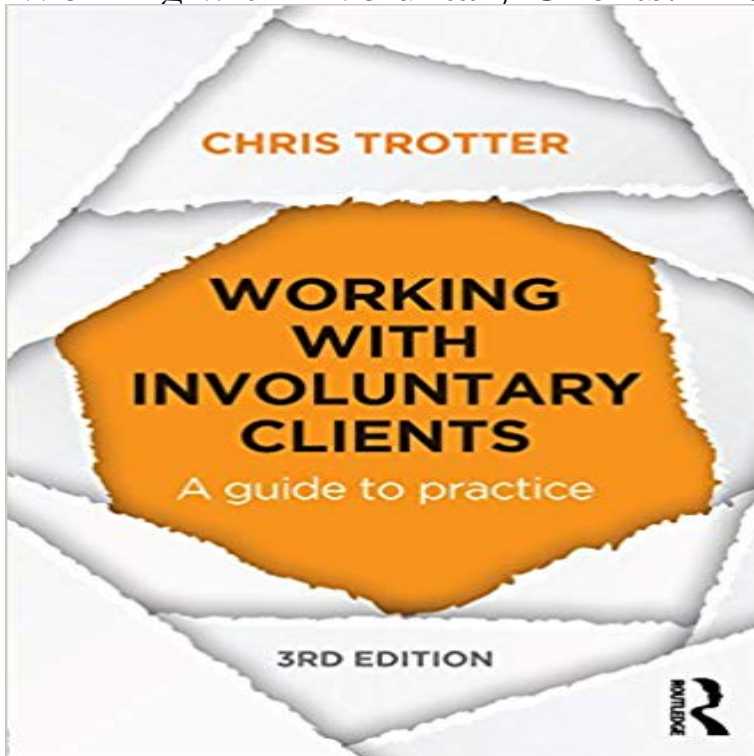


Working with Involuntary Clients: A Guide to Practice
